- 2. We hereby agree that your negotiation/discount of said draft(s) and/or documents is done on a "with recourse" basis. Therefore, in the event of non-payment and/or non-acceptance of said draft(s) and/or documents, either by reason of any discrepancy raised by the issuing bank or by other reasons whatsoever, we undertake to refund to you the foreign currency amount of such draft(s) and/or documents together with interest thereon at the maximum default rate* from the date of disposition of proceeds as above mentioned until full payment thereof.
- 3. We further undertake to pay you the charges and/or fees incurred in connection with the collection/negotiation/discount hereunder at the rate prescribed by you from time to time and to hold you free and harmless from and against all expenses, losses and damages howsoever incurred and/or may be incurred to you in consequence of your collection/negotiation/discount of the above mentioned draft(s) and/or documents, in which case we agree to fully indemnify you immediately upon our receipt of your notice to that effect.
- 4. We hereby agree that this will serve as your authority to charge our account with the Baht equivalent of the draft(s) and/or documents amount at the then prevailing bank's selling rate, including interest and all other costs and expenses.
- 5. We further agree that your collection/negotiation/discount of our above mentioned draft(s) and/or documents is subject to the version of the ICC Uniform Customs and Practice for Documentary Credits, International Chamber of Commerce stated in the Documentary Credit.
- 6. We agree that this Application shall be governed by and construed in accordance with the law of Thailand.

*The maximum default rate referred to herein means the maximum interest rate announced by Bank of Ayudhya Public Company Limited from time to time pursuant to the announcement of the Bank of Thailand regarding the instruction for commercial banks to perform with respect to interest and discount rate.
