1. The Applicant can use Krungsri Tradelink System via https://www.krungsritradelink.com which is available on internet

The Applicant agrees and consents to be bound by and comply with the terms and conditions for the use of Krungsri

- network system.

 2. The Bank shall specify and provide user identification number (User ID), Password and devices to be used with User
- ID and Password to ensure security (TOKEN) to the Applicant in accordance with the number of persons who are entitled to use the system as informed by the Applicant, hereinafter referred to as the "User".

The Applicant shall keep User ID and Password confidential and shall not disclose User ID and Password to any irrelevant person or consent to other person to use the Password. The Applicant shall also keep TOKEN in a safe place where no one has access to and shall supervise and ensure that the User complies with the foregoing provisions. Upon the termination of the service, the Applicant shall return TOKEN to the Bank immediately.

3. The Applicant acknowledges that for logging in into Krungsri Tradelink System, User ID and Password provided by the Bank shall be used in accordance with the conditions and procedures determined by the Bank. If it appears that Krungsri Tradelink System is used by the USER ID and Password of the Applicant, the Applicant accepts that such use shall be valid and binding upon the Applicant. In this regard, the Applicant agrees to be liable for any payment of debt as well as any damages incurred from the use of Krungsri Tradelink System of the Applicant under this Application based mainly on the contents which have been processed and appeared in computer system of the Bank. For the said purpose, the Bank is not obliged to verify the correctness of original data or authorization for finding out whether Krungsri Tradelink System has been used by the Applicant or not.

The Applicant acknowledges that the Bank has the right to suspend the use of service via Krungsri Tradelink System if there is use of wrong passwords exceeding the times determined by the Bank until the Applicant changes the Password in accordance with the procedures and method determined by the Bank. If the Applicant suspects that the Password has been used for logging in into the system by any unauthorized person, the Applicant shall notify the Bank immediately in order to change

the Password. The Applicant agrees that each new password shall be the password for the use of service which will be binding upon the Applicant in all aspects.

- 4. The Applicant acknowledges that if the Bank's computer system, computer, equipment, telecommunication system, network and/or internet system program is/are out of order, down or being repaired or maintained or there is any other force majeure that is beyond the Bank's control which causes the Bank to be unable to render the service to the Applicant, the Applicant agrees that he/she will not raise the said cause against the Bank to take responsibility to the Applicant except for the cause attributable to the Bank's gross negligence.
- 5. The Applicant accepts that any records, evidences or documents prepared by the Bank as a result of the use of service by the Applicant are correct and can be lawfully used as evidence against the Applicant and other persons using the service with the Applicant for the purpose of proving sources of debts, deductions, transfers of money and/or any other services regardless of whether the said information is stored and/or collected in electronic form or any other form. In this regard, the Applicant shall have the right to receive the evidences of the transactions under this Application subject to the procedures and methods determined by the Bank.
- 6. The Applicant agrees and consents to pay fees and expenses related to the use of Krungsri Tradelink System as well as expenses incurred from the transactions performed subject to the scope of each service specified in the document attached to the Application to the Bank at a rate announced by the Bank. For the said purpose, the Applicant consents that the Bank shall have the right to deduct the fees and expenses from the Applicant's account opened with the Bank without a prior notice to the Applicant, and consents to make the payment to the Bank by any other means agreed by the Applicant and the Bank.
- 7. The Applicant acknowledges that the Bank reserves the right to cancel the service of Krungsri Tradelink System at any time by giving a notice to the Applicant.
- 8. The Applicant agrees to be bound by and comply with the terms and conditions for the use of Krungsri Tradelink specified herein and the attachment which provides the terms and conditions for each type of service for which the Applicant agrees to use as well as manuals or all documents related to the use of Krungsri Tradelink System which are currently available and/or will be specified by the Bank in the future. The said documents shall be deemed to form an integral part of this Application.
- 9. The Applicant acknowledges that the Bank shall have the right to amend or change the terms and conditions for the use of Krungsri Tradelink System as it deems appropriate by giving a notice to the Applicant at least thirty (30) days prior to the date such change takes effect. In this regard, if such amendment of the Bank causes the Applicant's expenses or responsibility being increased, the Applicant may cancel the service.
- 10. This Application shall be effective from the date of signing by the Applicant until the Applicant notifies the Bank of the cancellation of the service in accordance with the procedures and methods determined by the Bank and the Applicant has already received the copy of this Application from the Bank.
- 11. The Applicant acknowledges that the Bank shall perform the transaction according to the information received from the Applicant as per this Application only on the banking day, provided, however, that the Bank must receive the required and completed information within the Cut-Off Time specified and informed by the Bank from time to time. For information received by the Bank after Cut-Off Time, the Bank will process the transaction in accordance with that information on the next business day.

12. The Applicant acknowledges that in the case the Applicant wishes to cancel or change the rights to use the Krungsri Tradelink System, the Applicant must notify the Bank in writing and thereafter the Bank will proceed in accordance with the procedures and methods specified by the Bank.

13. To the extent of utilization of service hereunder, the Applicant acknowledges that in case where the Applicant does the transaction by using Password without TOKEN for the service of opening or amendment of the Letter of Credit or the service of transferring of the foreign currency with the Bank, as and when the transaction is approved via computer system by the Bank, the Applicant shall print out the Application for opening and /or amendment of the Letter of Credit or the transferring of foreign currency, (as the case may be) in the form prescribed by the Bank together with affix the signature of authorized person and deliver such to the Bank within 7 days from the transaction date.

To the extent of utilization of service hereunder, the Applicant acknowledges that in case where the Applicant does the transaction by using Password with TOKEN for the service of opening or amendment of the Letter of Credit or the service of transferring of the foreign currency with the Bank, as and when the transaction is approved via computer system by the Bank, the Applicant is not required to print out the Application for opening and /or amendment of the Letter of Credit or the transferring of foreign currency, (as the case may be)

14. The Applicant acknowledges that in the case that the Applicant wishes to apply for the service of Host-to-Host data transfer via Krungsri Data Express directly connected to the Krungsri Tradelink system with the Host-to-Host - Straight Through Processing format, it is a data transfer service for Host-to-Host without waiting for additional approval of the Applicant through the Krungsri TradeLink system.

15. The Applicant acknowledges that in the case that the Applicant wishes to apply for the service of Host-to-Host data transfer via Krungsri Data Express directly connected to the Krungsri Tradelink system with the Host-to-Host - Semi Straight Through Processing format, it is a data transfer service requiring additional approval of the Applicant through the Krungsri TradeLink system in accordance with the terms and conditions of the Krungsri Tradelink system.

16. Not with standing anything in this Application to the contrary, upon being requested by the Bank at its sole discretion, the Applicant shall furnish an original of the Application for Opening or Amendment of the Letter of Credit to the Bank and/or an original of the foreign currency transfer request to the Bank within seven (7) days from the date of receiving a notice from the Bank.
